Dealer Rules

The fee for each 8' table and two chairs is \$160. Table locations will be assigned; no changes or subletting is permitted. San Diego Miniature Crafters reserve the right to make changes, if necessary.

No more than two people are allowed behind the table at the same time. No one under sixteen will be allowed behind sales tables.

Sales table set up will be Saturday no earlier than 7:00 am; doors will open to the public at 10 am.

Dealers agree to sell only during the hours specified on the contract. Public hours: Saturday 10am-5pm, Sunday 11am-4pm.

Tables may not be taken down before 4:00 pm Sunday. Dealer tables must be clear by 6:30 pm or a fee may be charged.

Dealers will be responsible for their property during set-up, sales hours and take-down. If desired, please provide a cover for your merchandise during non-sale hours.

The Rio Vista Ballroom will be secured during nonbusiness hours. Neither San Diego Miniature Crafters nor the manager or owner of the Marriott Mission Valley shall be responsible for personal injury, loss of goods or merchandise or any action which may occur for the duration of the show.

Black tablecloths will be provided. You may layer your own for a personal touch.

Indicate on the contract if you will need electricity so that tables may be placed in close proximity to outlets. Please provide your own appropriate extension cord/cords. *Do not disconnect power strips/cords.*

No raffles, drawings or silent auctions of any type are allowed at dealer/sales tables.

Dealers must have a current California Sales Tax License. Dealer is solely responsible for any tax liabilities as required by law.

The signed contract and a check, cash or PayPal for either the full amount or a 50% deposit must be received by December 14, 2018. Final payment must be received by January 4, 2019. If you would like to pay with your PayPal account our email is: sd.minishow@gmail.com.

Until we have a fully completed contract and deposit, we cannot confirm your reservation. The Dealer Contract does not become valid until your check has cleared the bank or payment is received via PayPal. There will be a \$35.00 charge for any check returned by the bank.

Receipt of your signed contract and deposit/payment is not a guarantee of dealer space. You will receive confirmation of your reservation.

Cancellation must be in writing. A full refund will be given if cancellation is received by January 4, 2019. Refunds after that date will be made only if a replacement dealer is found. This dealer contract is non transferable.

Please retain a copy of "Dealer Rules" and "Dealer Contract" for your records.

Any flyers/brochures that advertise shops, shows, etc. must be placed on the literature table and only with the approval of San Diego Miniature Crafters. Distribution of literature in the aisles is prohibited.
